The Biopsychosocial Model and Case Formulation (also known as the Biopsychosocial Formulation) in psychiatry is a way of understanding a patient as more than a diagnostic label. Hypotheses are generated about the origins and causes of a patient's symptoms. The most common and clinically practical way to formulate is through the biopsychosocial approach, first described in 1980 by George Engel.

The following guidelines for case formulation (Persons, 2001), if used, will add to the initial assessment, and are consistent with the cognitive behavioural approach of this intervention. A clinical formulation, also called a 'case formulation', looks at the nature and cause of your issues as a client, and then works to create a hypothesis, a starting point for further exploration. In other words, a formulation is a 'blueprint' for what is going on with you and how you therapist might help.
